

Takikawa City Business Support Cash Payment

What is this payment??

This is a payment to support businesses in Takikawa during the difficult economic environment caused by the spread of COVID-19



Corporations or individuals can receive

¥ 100,000

Who is eligible??

Entities conducting business activities in Takikawa City who meet certain requirements, including small and medium businesses, self-employed individuals such as freelancers, medical organizations, NPOs, etc.



Anyone who reports receipt of “*jigyou-shuunyuu*” (business income) on their tax return, such as freelance web designers or photographers, or contract construction workers, is eligible.

What conditions apply??

To qualify you must have a month of business income on or after January 2020 that is between 30% and 50% lower than the same month of the previous year, and not be eligible for national “*jizokuka-kyuufukin*” (continuing payments) on the date of your application.



For those who began their business activities on or after January 2019 (for over 3 months), a simple comparison to the previous year is not possible, so there is a separate procedure. See next pages for details.

Application Period

July 1st (Wed) ~ September 30th (Wed), 2020

How to apply

Mail in paper application and attached documents

STEP 1

Complete the Takikawa City Business Support Cash Payment application form.



STEP 2

Attach necessary Documents such as copies of sales ledgers or tax returns



STEP 3

Mail application to the Takikawa City Business Support Cash Payment office.

※ Applications are available at the city’s website, Takikawa City Hall, the Takikawa Chamber of Commerce, and the Ebeotsu Chamber of Commerce.

※ We will mail notices and deposit payments approximately 2 weeks after receipt of application.

Eligible entities

- ① Corporations and individuals conducting business in Takikawa City, and who intend to continue their business activities going forward (however, for corporations, capital may not exceed ¥ 1,000,000,000 (one billion yen)).
- ② As a result of the spread of COVID-19, had a month between January 2020 and the month prior to application in which business income was between 30% and 50% lower than that of the same month in the previous year.
 - ※ This requirement may vary depending on starting date of business, etc. For details, please check the “Payment conditions by business category” table.
- ③ On the date of application, may not be eligible for national “*jizokuka-kyuufukin*” (continuing payments)
- ④ Political or religious organizations are not eligible.

Entities that cannot simply compare business income to previous year

For entities that incorporated, privatized, or were inherited in between the 2 months of comparison, we can still compare with the relevant business income of the previous entity.

For specified nonprofit corporations, charitable corporations, etc., we can use operating profits excluding subsidies for comparison, and for entities with a disaster certificate we can change the year of comparison to the year before last.

Entities who wish to request these special cases be applied will need to supply additional documentation with their application, so please inquire with our office.

Application documents

To apply, please assemble and mail the following documents to the address below.

※ Except for the application form, you may submit copies of all other documents.

《Corporations》

- ① Takikawa City Business Support Cash Payment Application form (application)
- ② Evidence of all monthly business income in 2020 (e.g. ledgers, trial balance sheets)
- ③ Copy of annual tax return table 1 including month of business income for comparison with ②, and copy of Corporate Business Overview Manual.
- ④ Certificate of All Historical Matters
- ⑤ Evidence of business activities being conducted in Takikawa City (can be omitted if corporate address on Certificate of All Historical Matters is in Takikawa City)
- ⑥ Copy of bank book in corporation's name used for bank transfers

《Individuals》

- ① Takikawa City Business Support Cash Payment Application form (application)
- ② Evidence of all monthly business income in 2020 (e.g. ledgers, trial balance sheets)
- ③ Copies of 2020 tax return table 1, and blue financial declaration (those who filed white declarations can omit)
- ④ Evidence of business activities being conducted in Takikawa City (e.g. opening or closing of business notifications. Can be omitted if applicant's registered address is in Takikawa)
- ⑤ Copy of bank book in individual's name used for bank transfers
- ⑥ Personal identification (e.g. driver's license, passport, Personal Number Card, Basic Resident Register Card, Special Permanent Resident Certificate, etc.)

Businesses started before December 31, 2018

Cat. A

《Payment conditions》 ※Fulfill all of ① and ②

- ① Must have a month of business income on or after January 2020 that is between 30% and 50% lower than the same month of the previous year.
 - ② 「Previous year's total business income - (lower month × 12)」 must be at least ¥ 100,000.
- ※ Previous year's total business income: for corporations, total figure for the fiscal year including the comparison month; for individuals, total figure in 2019.
- ※ Calculation of business income shall be treated the same as the sum reported on your tax return.

Entities not fulfilling ② but who are deemed to have "monthly income that has greatly fluctuated" may be eligible for payment under the following conditions.

《Payment conditions》 ※Fulfill all of ① and ②

- ① Must have a period of 3 consecutive months starting on or after January 2020 in which total business income is between 30% and 50% lower than the same period of the previous year.
- ② 「Business income from previous year's period - business income from period in ①」 must be at least ¥ 100,000.

Cat. B

- ※ Entities may be deemed to have "monthly income that has greatly fluctuated" if 「business income from previous year's period」 is equivalent to at least 50% of the corresponding fiscal year's total business income (for individuals, if the same is equivalent to at least 50% their 2019 business income).

Businesses started between January and December 2019

Cat. C

《Payment conditions》 ※Fulfill all of ① and ②

- ① Must have a month of business income on or after January 2020 that is between 30% and 50% lower than the monthly average business income calculated from total business income in 2019.
 - ② 「(Previous year's monthly average × 12) - (lower month × 12)」 must be at least ¥ 100,000.
- ※ Previous year's monthly average income for entities established in 2019 will be calculated by dividing business income in 2019 by the number of months from start of business to December 2019.
- ※ This process will be the same for both individuals and corporations.

Businesses started on or after January 2020

Cat. D

《Payment conditions》 ※Fulfill all of ① and ②

- ① Must have a month of business income on or after January 2020 that is at least 30% lower than the monthly average of 3 consecutive months in 2020 including the lower month.
- ② 「(3-month average × 4) - (lower month × 12)」 must be at least ¥ 100,000.
